



Hiring careless or unsafe drivers is a major risk that all employees would like to avoid. Unqualified drivers are more at risk of being involved in an accident, which may result in litigation and unnecessary costs for their employers.

CDLIS can help eliminate a candidate who does not hold a valid Commercial Driver's License. This search also makes it simple to identify any additional licenses an applicant has previously held. In addition, CDLIS is the only known source to check if an applicant holds more than one commercial driver's licenses simultaneously.

Compliance

All State agencies are mandated to store and provide information to the Commercial Driver License System (CDLIS) about the Commercial driver's licenses they administer. This information constitutes a driver's unique CDLIS Master Pointer Record (MPR). This database is administered by AAMVA.

Risk Management

The FMCSA requires an inquiry into a driver's record during the preceding three years. The inquiry must be submitted to the appropriate agency of every State in which the driver was issued a license or permit during those three years. Some drivers have a tendency to not reveal their bad driving histories or any prior states in which they may have been licensed.
